Director Sheets Harassing Behavior via the LCARC Repeaters

Introduction

- Henry Sheets, KA9GKT has engaged in harassment on and off the air since January 2024.
- During this time and with knowledge of current and former LCARC directors of this harassment, Mr. Sheets was appointed a Director of LCARC.
- The harassment is unwarranted, unprovoked and has not been responded to in any form, other than reaching out to LCARC directors
- This presentation is a compilation of the most egregious behavior of Director Sheets.

History

- In 2024 Mr. Crozier requested Mr. Sheets refrain from explicit conversation on the KA9QJG repeaters. This was fully within Mr. Crozier's rights as the licensee.
- Since that time, Mr. Sheets has insulted, bullied, and casually referenced Mr. Crozier and his family in most conversations he has on local repeaters.
- Mr. Crozier took the steps to formally ban Mr. Sheets from his repeater in August 2024.

Regarding your operations on KA9QJG and other repeater systems

Mr. Sheets,

I am the control operator of the KA9QJG repeater system, licensed by the Federal Communications Commission (FCC). I am writing regarding your ongoing operations on this and other local repeater systems which appear to be in violation of FCC rules, Indiana civil and criminal law, and common decency. I refer to 47 CFR §97.1 Basis and Purpose of amateur radio and §97.113 prohibited transmissions. Specifically, §97.113(a)(4)'s prohibition on obscene, false or deceptive communications and prohibition of use of amateur radio in a criminal act. Your engagement in ad hominem attacks, vile and obscene comments to others, and slanderous, deceptive and/or obscene communications regarding my family and/or myself are not only improper use of amateur radio but rise to the level of criminal harassment and/or intimidation under Indiana Criminal Code.

I demand you immediately cease these activities and your misuse of communications devices in regards to the above.

Further, in my capacity as the control operator of the KA9QJG repeaters, in accordance with 47 CFR §97.205(e) I may limit the users of these repeaters, and you are no longer a permitted user of my repeater systems.


You are to immediately cease operations on any KA9QJG repeater systems.



Records of Director Sheets

- The next slides are a small subset of what has been recorded.
- Starting in February 2025, an AI enabled multichannel recorder which transcribed audio to text was setup to record 147.000 and other local repeaters.

- This was distilled into a spreadsheet for relevant conversations of Mr.
 Sheets. It it browsable here
- A more detailed writeup was shared as written document.
- We are happy to provide any further evidence at LCARC's request.

Director Sheets Boasting

In several instances Director Sheets boasts of his new found "authority"

- From his QRZ Page:
 - 03-14-2025 I have become one of seven directors of the Lake County Amaetur radio club, LCARC a very privilaged club here in Lake County Indiana. I was elected by by peers of my merit in amateur radio (no buying a way into this club!).
- I was appointed one of the directors, too, by the way, Rob.
 So if you go on the Lake County website, you'll see my name in there.
 I approved myself as a truthful, civic-minded American citizen that I was appointed.
- I didn't buy my way, like some people would.
- Uh, you know, not to make myself look like a big celebrity. I'm already maybe a celebrity. I mean, I'm, like I said before, I'm more popular than Elvis Presley.

Director Sheets 911 Call

- On April 18, 2025 Director Sheets called Lake County 911 to make a false report on Mr. Crozier.
- Mr. Fields was on the phone with Mr. Crozier when the police showed up and had been for about 35 min prior. At no time was Mr. Crozier on the radio during this time.
- The officer found no basis in fact for the report and left.

This could have been much worse, and is known as a Swatting.

A Sad Situation

- This is only a small subset of the collected evidence.
- We found over 150 instances since February 9, 2025.
- As this has been going on since January 2024, the true number of instances is in the thousands.
- Each time Mr. Sheets was counseled on this behavior, he eventually restarted it.
- This marks the second time in recent memory that LCARC has appointed someone to a directorship who lacks the morality and good judgment to be a director of the organization.

A Way Forward for LCARC

LCARC doesn't have the financial resources to indemnify it's Directors.

- LCARC is at a crossroads
 - One they could close the club and shut down, leaving a hole in NWI radio
 - Two the board could choose to operate the organization like a first-class club
- Our demands are noncontroversial if LCARC is committed to option two.

Demands of LCARC

- Repudiate, admonish, and expel Henry Sheets, KA9GKT through a finding of facts and ban him from club repeater systems. This is to be published on the LCARC website
- The organization <u>formally apologizes to Mr. Crozier and his wife for the deeply offensive</u> <u>comments by director Sheets</u>. This is to be published on the LCARC website
- Establish open records through posting on the website, Articles of Incorporation, Bylaws, meeting minutes, yearly IRS forms (990), and a quarterly statement of accounting.
- Establish character standards for directors and leadership.
- Admit Mr. Crozier as an honorary member owing to his lifelong commitment to the betterment of amateur radio in the area.
- Admit Mr. Fields as a member in good standing retroactive to the date his mail was received.
