FIELD SERVICE BULLETIN

SUBJECT: Dropped audio for a subscriber in a SmartX site with Astro 25 Quantar base station.

MODEL / SYSTEM AFFECTED:

Astro 7.7, Astro 7.8 SmartX Site Converter (B1933A with CA01401AA):

SYMPTOM:

The applicable call scenario occurs when a subscriber on a 3600/SmartX site is sourcing audio on a call involving a destination radio at a ASTRO 25 RF site. To encounter the problem, the ASTRO 25 site must be using a Quantar series station on the assigned station. An ASTRO 25 destination site containing GTR (Summit) series stations will not encounter this problem. Further, during the course of the call the audio stream received on the 3600/SmartX site must suffer at least a 200 millisecond gap. Once the 200 millisecond gap is encountered, the ASTRO 25/Quantar site will drop audio for the duration of the PTT. The other destinations in the call (other SmartX sites, GTR ASTRO 25 sites, consoles) will hear the gap, but the audio for the PTT will continue to be played after the audio gap.

CAUSE:

This issue is caused by a defect in the Astro 7.7 and Astro 7.8, SmartX, Site Converter software.

RESOLUTION:

This defect is fixed in Astro 7.7 SmartX Site Converter Software, KC443C019000007740, R7.7.00.14 This defect is fixed in Astro 7.8 SmartX Site Converter Software, KC443C019000007810, R7.8.00.10

Software can be obtained by opening a software case with the System Support Center (SSC) at 800-221-7144 and then completing and faxing, or emailing, the attached software order form.

High - Perform Immediately
